hereby declare to have read and understood the following:

Under the authority of the General Consulate of Italy in Los Angeles, CA (U.S.A.), the Honorary Consulate of Italy in Arizona (U.S.A.) is authorized to discharge the following official duties:

- a. To receive and forward, to the General Consulate of Italy in Los Angeles, vital records of Italian citizens residing within the assigned jurisdiction;
- b. To receive and forward, to the General Consulate of Italy in Los Angeles, applications to be enrolled in the Italian voters' lists and Vital Statistics Registries presented by Italian nationals residing within the assigned jurisdiction;
- c. To receive and forward, to the General Consulate of Italy in Los Angeles, documents pertaining Italian retirement benefits;
- d. Administrative verification of signatures affixed by Italian citizen, when provided under Italian law;
- e. To receive and forward, to the General Consulate of Italy in Los Angeles, any supporting document pertaining the issuance of an Italian passport to Italian nationals residing within the assigned jurisdiction;
- f. Collection of fingerprints to be used exclusively for the issuance of an Italian passport pertaining Italian citizens residing within the assigned jurisdiction who are in compliance with the AIRE requirement **and present adequate supporting evidence proving their actual registration in the AIRE database;**
- g. To receive and forward, to the General Consulate of Italy in Los Angeles, applications to receive an Emergency Travel Document [EDT] presented by Italian citizens or by citizens of any other EU Member States and follow-up delivery, when provided under the applicable law;
- h. To receive and forward, to the General Consulate of Italy in Los Angeles, any supporting document pertaining Visa applications;
- i. To assist Italian citizens in distress to apply for short-term loans repayable to the Italian Treasury.

Consular fees due for the discharge of the above-listed activities are pre-set under Italian law and are updated on a quarterly basis (please make sure to verify the applicable "consular fees" directly on the web site of the General Consulate of Italy in Los Angeles: https://conslosangeles.esteri.it/consolato_losangeles/en/). The same table is also published on the website of the Honorary Consulate of Italy in Arizona.

Italian citizenship matters are not included in the scope of the authority assigned to the Honorary Consulate, and all applications for Italian citizenship must be processed directly and exclusively through the General Consulate of Italy in Los Angeles. Any other service not included in the above list of official duties is not to be considered a public service offered by the Honorary Consulate. More specifically, any other services rendered by local professionals to prepare individual applications, or even by the Honorary Consul in his/her private practice and within the scope of the professional activity which he/she is authorized to perform under verified credentials required by the applicable law, are not part of the Honorary Consulate's activities.
